Notification

Consequent upon the recommendations of the Committee to develop Framework/Policy for International students to conduct part of their Doctoral Thesis at Government College University, Faisalabad made in its meeting held on 08-04-2022, the Vice Chancellor is pleased to grant approval to design the Policy Framework for the said purpose by including the following clauses:-

- 1. An MoU must be signed between the Parent University and GCUF, for the research collaboration and student exchange to conduct part of their research work at GCUF.
- 2. Supervisor of international student, who intends to conduct a part of his/her research work at GCUF, should either directly contact Directorate of International Linkages or through the relevant department. If needed, the directorate will help the scholar to identify a relevant researcher/supervisor and to proceed for MoU and other relevant documentation.
- 3. Supervisor of the Scholar from Parent University shall be recognized as Major Supervisor/Supervisor-I and faculty member/ researcher of host lab (GCUF) will act as Co-Supervisor/Supervisor-II or relevant nomenclature for both supervisors/researchers as per rules of universities.
- 4. The Supervisor-II will be responsible to provide general Lab placement facility and intellectual guidance keeping the Supervisor-I in the loop to conduct a part of research at GCUF.
- 5. In this collaborative research work, Supervisor-I may provide stipend/financial support/health insurance/living allowance to the scholar and Supervisor-I will be responsible to provide any chemicals, consumable, kits, or any other research related material/analyses required for the student's work on need basis to the student concerned or the host lab directly through mutual understanding with the host supervisor OR the student must deposit a bench Fee (USD 109/Semester) to

facilitate the students for lab reagents and remuneration of supervisor -II as per university policy.

- 6. The bench fee may be waived-off if the Foreign and GCUF labs are already working in collaboration under a previously signed MoU. The collaboration will be assessed through collaborative fundings/publications etc. However, any waivers will be implemented with the prior approval from the office of the Vice Chancellor's through relevant Chairperson and Dean.
- 7. As per clause 5 & 6 of this documents the students from GCUF can also enjoy the same facilities at the partner institute.
- 8. Any research paper/patent/product developed from the study will be the shared as an intellectual property between the both the labs with mutual understanding as per international norms.
- 9. If needed, accommodation will be responsibility of concerned student; however, supervisor-II can help the student to arrange the accommodation subject to the availability after seeking a case-to-case basis prior approval from the office of the Vice Chancellor, GCUF.
- 10.Students will be responsible to abide by all the rules and regulations, enforced by GCUF.
- 11. The studentship will be notified yearly basis and in case of violation of rules and regulations, studentship may be cancelled after issuance of notice to the students and the Parent University.
