**ADMISSION POLICY FOR SESSION 2023-2024 FOR AFFILIATED COLLEGES
(GOVERNMENT AND PRIVATE) GOVERNMENT COLLEGE UNIVERSITY, FAISALABAD**


The Admission Policy for the year 2023-2024 for the Colleges/Institutes (Government and Private) affiliated to the Government College University, Faisalabad is as under:

Admissions rules of Government College University, Faisalabad as per its Prospectus 2023-2024 (available online) will be implemented in all Government and Private affiliated Institutes / Colleges with the following exceptions for the session 2023-2024;

1. There will be quota for employee's son/daughter, sports, co-curricular, disabled (one seat each in a program) only in Affiliated Government colleges;
2. For morning BS and ADP programmes, age limit along with relaxation will be 22+3=25 years only. (age will be calculated from the closing date of admissions as decided/extended by the University;
3. For Evening Programmes, the age limit will be 24 + 3 = 27 years only, (age will be calculated from the closing date of admissions as decided/extended by the University;
4. Closing date for admission to all BS and ADP programmes is **31.08.2023** for all Government and 15 days gap **15.09.2023** for Private Affiliated Colleges. Afterwards, fine will be charged on weekly basis. After that no case for registration will be entertained. All vouchers will be generated electronically and college concerned should submit/deposit dues as per the dates mentioned on the vouchers;
5. The Registration Return Files should be submitted on or before **15.10.2023** in the University Registration Branch. In case of failure to submit registration files within the prescribed time, fine will be charged as per policy mentioned above;
6. All Government and Private affiliated Colleges will only admit eligible candidates having domicile(s) of Punjab. However, the Government and Private colleges situated at Islamabad can admit eligible candidates having domicile(s) of Punjab and Islamabad, ICT territory subject to any policy approved by Government College University, Faisalabad's Authority and NOC from HEC.
7. As per instructions of HEC, verification of SSC/HSSC of the students admitted to all BS programs (4-year and 5-year) from the Inter Board Committee of Chairmen (IBCC) is mandatory w.e.f. Fall Semester, 2023. Accordingly, the admitted students will submit their Matric and Intermediate certificates duly verified by the IBCC within first semester. The College will add these Certificates to their Student's Files and will provide the list of their students' SSC/HSSC Certificates verified from IBCC to the Directorate of Undergraduate Studies within first semester. **Please note that in case of any issue of verification of their Matric and/or Intermediate Certificate after admission, their admission will stand cancelled with no liability on the part of GC University, Faisalabad.**
