The Vice Chancellor is pleased to grant approval to the following revised rules for the summer semester 2024 for Government College University, Faisalabad, Main Campus, Sub-Campuses and Affiliated Colleges are as under:-

Summer Semester 2024



Rules No. 9 of the Semester Rules of the University regarding summer semester modified for one time only are as under:-

- 9.1. A student who wants to take "Audit", or "Deficiency" and "failed" courses he/she may enroll in summer semester.
- 9.2. In case of the Deficiency courses only two courses will be offered, the teacher will compulsorily complete 48 contact hours in case of 3 credit hours course and 64 contact hours in case of 4 credit hour course during 06 weeks.
- 9.3. All other student shall only be allowed to register three courses (failed /improvement cases) whereas BS bridging students can enroll three courses (two deficiency + one failed/ D grades) or three failed/D grade courses.
- 9.4. A last semester student who wants to improve his/her "D" grade or lowest grade with CGPA (less than 2.0 for BS 8th, 10th & BS bridging 8th and less than 2.5 for MPhil 2nd and less than 3 for PhD 2nd) will be allowed.
- 9.5. Other than last semester students who want to improve his/her "D" grade or lowest grade may be allowed to register three courses in summer irrespective of the CGPA. .
- 9.6. In the summer semester a course will be offered for minimum one student only for last semester and expected dropout students.
- 9.7. Rs. 5000/- fee will be charged per course per student.
- 9.8. A teacher shall be allowed to teach not more than three courses in summer, and he will be paid as per university rule after verification from Head of the concerned departments (in case of deficiency courses of bridging semester only). In case of online classes screenshot of attendance verified by Head of the concerned departments are compulsory for remuneration. The summer remuneration will be 40% of fee paid per student upto maximum of Rs. 40000/- per class.
- 9.9. The decision of the drop out of final year students will be finalized after completion of summer semester.
- 9.10. The failed subjects of the respective academic year (2023- 24) may be clear in summer of that academic year i.e. Summer 2024 and onward.

Furthermore, the students of Affiliated Colleges on the recommendation of the concerned Principal may also be allowed to enroll in the Summer Semester 2024 at their respective sub campuses and in case of non-availability of nearby sub campus students will be enrolled for online classes with main campus with Subject to the following conditions.

4. The complete list of No. of students in different courses with full details will be provided.
5. The 30% of the fee per student per course will be paid to University at the time of registration.
6. No registration will be entertained after last date of registration
